**NOW THEREFORE IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU. THE PARTIES HERE TO AGREE AS FOLLOWS.**

#### **CLAUSE I**

##### **CO-OPERATION**

1.1 Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Mahavir Mahavidyalaya, and its related wings the parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another

1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing suitable teaching/ training systems, keeping in mind the needs of the industry the Second Party.

1.3 The general terms of co-operation shall be governed by this MoU. The parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MoU. The term of Definitive Documents, this MoU shall represent the entire understandings as to the subject matter here of and shall supersede any prior understanding between the Parties on the subject matter hereof.

#### **CLAUSE 2**

##### **SCOPE OF THE MoU**

**2.1 Skill Development :** The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

**2.2 Curriculum Design :** Second Party will give valuable inputs to the First Party in training methodology and suitably customize the curriculum so that students fit into the industrial scenario meaningfully.

**2.3 Project/Plant site visits -** Site visits will give an insight in to the latest developments/requirements of the project/plant, the Second Party to permit the Faculty and Students of the First Party to be involved in the training sessions arranged for the First Party,

if any. The training and exposure provided to students and faculty through will build confidence and prepare the student to have a smooth transition from academic to working career. The Second Party will provide its project/ plant site for the hands-on training of the learners enrolled with the First Party.

**2.4 Research and Development :** Both parties have agreed to carry out the joint research activities in the fields of **agriculture, irrigation, rural development, farmers Empowerment, rural economy, environment conservation, micro irrigation and agricultural engineering.**

**2.5 Skill Development Programs :** Second Party to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them industry ready.

**2.6 Guest Lectures :** Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.

**2.7 Faculty Development Programs :** Second Party to train the Faculties of First Party as and when possible by imparting training in the concerned sector.

**2.8 Trained Students :** Second Party will as much as possible engage in helping the delivery of training and placements of the students of the first party into internships / jobs, and facilitate placements for the students.

**2.9 Financial Commitment :** There is no financial commitment on the part of the Mahavir Mahavidyalaya, the first party to take up any programme mentioned in the MoU. If there is any financial consideration, it will be dealt separately.

### **CLAUSE 3**

#### **INTELLECTUAL PROPERTY**

3.1 Nothing contained in this MoU shall, by express grant, implication, or otherwise, create in either Party any right, title, interest, or licences to the intellectual property. (including but not limited to know-how, inventions, patents, copy, rights and designs) of the other Party.

### **CLAUSE 4**

#### **VALIDITY**

4.1 This Agreement will be valid until it is expressly terminate by either Party on mutually agreed terms, during which period **Dr. D. Y. Patil College of Agricultural Engineering & Technology, Talsande..** The Second Party, as the case may be, will take effective steps for implementation of this MoU. Any act on the part of Training Partner or the Second Party after

termination of this Agreement way of communication, correspondence etc, shall not be construed as an extension of this MoU

4.2 Both Parties may terminate this MoU upon 30 calendar days notice in writing. In the event of Termination, both parties have to discharge their obligation.

##### RELATIONSHIP BETWEEN THE PARTIES

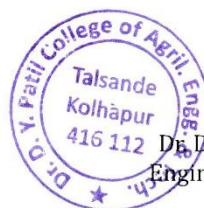
