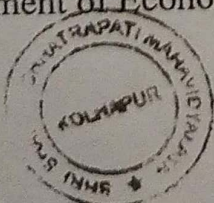

4. Duration of MOU

This MOU, unless extended by mutual written consent of the institutes, shall expire in FIVE years after the effective date specified in the opening paragraph (i.e. From 1st June, 2019 To 31st May, 2024). However, on review, the MOU shall be extended for another TWO years by mutual consent.

Both institutes will assign persons to take responsibility for coordinating and implementing of this MoU.


